

# Thathornycat's Commission Terms

## 1. General Terms

### 1.1. Commission Process.

1.1.A. You have to be older than 18 Years old to commission me.

I usually respond within 24 hours.

1.1.2. You must provide a Reference Sheet of all the characters involved as a file, in an imgur, google documents, furaffinity, inkbunny or other trustworthy link.

1.1.2.A. If you do not have a Reference Sheet, provide a detailed description of the Character that includes:

- 1) - Name.
- 2) - Age.
- 3) - Form. (Anthro, Feral, Scalie, Hybrid, etc.)
- 4) - Coloring of the fur. (must provide reference, or 1.1.3 applies.)
- 5) - Texture of the fur. (must provide reference, or 1.1.3 applies.)
- 6) - Specific pattern of the fur. (must provide reference, or 1.1.3 applies.)

1.1.2.B. And you must provide information on the following (if applies):

- 1) - Position. (Sitting, Standing, Laying, etc. (If any of these apply, provide details. A reference is not necessary. If not provided, 1.1.3 applies.)
- 2) - Dimensions. (Height, Width, Weight, etc. If necessary, provide dimensions or reference, or 1.1.3. applies.)
- 3) - Accessories. (If any of these apply, provide details. You must provide reference, or 1.1.3 applies.)
- 4) - Specifications to the Body. (Implants, Piercings, Scars, etc. If any of these apply, provide details. You must provide reference, or 1.1.3 applies.)
- 5) - Expressions. (You must provide reference, or 1.1.3. applies.)

You must provide all details you want to add at least after I send you the sketch. I want to get as much done in the sketch as possible. If you wish to change major things in the Linework, it might be charged in a separate invoice after negotiations. So let me know in time if you want more cum, more teeth to be shown or the foreskin more visible. Saves time and energy.

1.1.3. Artistic Freedom. (In connection to 1.1.2.A. and 1.1.2.B) If you do not provide a reference/information regarding a specific detail, you agree to leave that detail up to me. You can request alterations if you are not happy with what I came up with. Those wont be charged.

1.1.4. If you wish to have a specific background; submit at least 1 reference of the scenery. I need a general understanding of what you envision, so explain any necessary details. (Weather, Time of the day, etc.) If not provided, 1.1.3. applies.

1.1.5.A. If you wish to have specific objects in the scenery that are still, in use or held by a character, provide a reference for the object. Explain where it is standing or who and how it is being held. If not provided, 1.1.3. applies.

1.1.5.B. If you wish to have a specific shading/lighting style, you have to inform me before we agree on the total price. (If not specified, 1.1.3. applies.)

I offer the following shading/lighting styles:

- 1) - Cel
- 2) - Hatch & Crosshatch
- 3) - Screentone
- 4) - Airbrush
- 5) - Texture-Brush

If you want to know if I am willing to draw what you want me to draw, just ask. I am currently open for anything and will let you know if your idea is too much for me.

1.1.6. Edits, alterations and wishes for changes to accessories, positions, perspectives and characters have to be stated after the finished sketch has been shared.

1.1.8. Edits, alterations and wishes for changes to the linework have to be stated after the finished linework drawing has been shared.

1.1.9. Edits, alterations and wishes for changes to coloring, markings and anything else color related have to be stated after the finished colored drawing has been shared.

1.1.10. Edits, alterations and wishes for changes to shading, lighting and final touches have to be stated after the finished colored drawing has been shared.

1.1.11. Changes are free off charge, when 1.1.3. applied to what you want to have changed.

1.1.11.A. Changes can be charged, when the requested change is stated after the coloring or shading/lighting has been finished and send to you.

1.1.12.A. If you wish to receive alternative versions of the commission/s you have to tell be before the end of the price negotiation.

1.1.12.B. If you wish to have alternative versions after the payment, a price has to be negotiated for those alterations and will be charged with a separate invoice.

1.1.13.A. You must provide specifications of the Dimensions, DPI and Color Profile.

1.1.13.B. If you cannot provide, I will use the default A4, 2480px x 3508px, 210mm x 297mm, 300 DPI, sRGB IEC6 1966-2.1.

Once we agree to the completion of the commission/s, you can receive two versions via Email in the form of a PNG file. One version that is without and one that has a Watermark. Please ask me for that specifically.

1.1.14.A. You are not allowed to distribute the version that has no Watermark on. That version is for personal use only.

1.1.14.B. If you wish to distribute, share and send the finished file, you must use the version with the Watermark.

1.1.14.C. You are not obligated to credit me with a link whenever you decided to share the watermarked artwork.

1.1.15. If you wish to receive a specific file format, I can offer to send you the following alternatives:

- 1) - Procreate
- 2) - PSD
- 3) - PDF
- 4) - JPEG
- 5) - PNG
- 6) - TIFF
- 7) - Animated GIF
- 8) - Animated PNG
- 9) - Animated MP4
- 10) - Animated HEVC

When you commission a Sketch, Linework or Flat-Color, you can request the .tiff or .procreate file for forwarding it to another artist to finish.

#### 1.1.16. Deadlines.

1.1.16.A. I am not working with a set deadline unless agreed on otherwise.

1.1.16.B. If you wish the artwork to be finished within a certain time, you have to state that wish before or with in the price negotiations.

1.1.16.C. The current time-frame for finishing a commission is from 1 day to 3 months depending on the complexity and amount of the commissions I am currently working on.

Most commissions are finished within the first month but that is depending on how much you want to have changed in the process and on how quick we are communicating.

## 1.2. Legal Use Of Characters.

1.2.1. You confirm that you have the rights or permission to use all characters involved.

1.2.2. You confirm that you are aware of the Regulations of Distribution of Pornographic Material.

1.2.3. You are held fully liable for any violations of your local Regulations of the Distribution of Pornographic Material.

## 1.3. Copyright.

1.3.1. I retain the Copyright to every work of art I produce, including the rights;

1.3.1.A → to display it in any non-profitable or profitable way.

1.3.1.B. → to distribute it in any non-profitable or profitable way.

1.3.1.C. → to promote it in any non-profitable or profitable way.

1.3.2. You agree that I can use the artwork of your character for non-profitable and profitable ways as stated in 1.3.1.A., 1.3.1.B. and 1.3.1.C.

1.3.3. You can buy the Copyright of the artwork for 100% of the total price and are then allowed to;

1.3.3.A. → distribute, print, publish the Artwork without a watermark in commercial and profitable ways.

1.3.3.B. → make profits off the Artwork without a watermark on with;

1.3.3.B.1. → selling any physical goods with the Artwork printed on.

1.3.3.B.2. → selling any physical prints of the Artwork.

1.3.4. You have the full rights to print, use, distribute and display the artwork in a personal non-commercial way.

If you don't want me to distribute, sell or share your Commission, let me know and we will make it a Private Commission. I could ask for up to 50% of the price as a compensation for the loss of content that I can distribute.

## 1.4. Payments.

1.4.1. The accepted Payment Methods are the following:

- 1) Paypal Invoice (In USD or EUR)
- 2) Bank Transfer (In EUR)
- 3) Crypto (DOGE, ETH or suggest a Coin)

1.4.2.A. If payment is not made within the next 24h, you will be reminded.

1.4.2.B. If you do not reply within the next 48h, the commission will be canceled.

1.4.3. You can receive an official invoice within the next 14 days after the full sized artwork has been send to you via Email. Please ask me for that specifically.

## 1.5. Cancellation-Process and Fees.

1.5.1.A. You are allowed to cancel the commission after at least one of following steps have been reached:

- 1) Sketch
- 2) Linework
- 3) Color

1.5.1.B. If you cancel, the paid amount of money will be split in two in different amounts depending on the state of the progress.

### 1.5.1.B.1.

- 1) 75% of the full price will be refunded, if you cancel after the sketch has been finished and send to you.
- 2) 50% of the full price will be refunded, if you cancel after the linework has been finished and send to you.
- 3) 20% of the full price will be refunded, if you cancel after the coloring has been finished and send to you.

1.5.2. If you cancel, no edits, alterations or changes can be made anymore.

1.1.3. I can cancel the commission at any time. Cancellation fees of 1.1.16.B.1. apply.

1.1.4. The cancellation of the commission will be confirmed via Email within the next 24h.

1.1.5. The refund will be initiated within the next 3 days and confirmed to you via Email.
